



### Project types

#### Regular projects

- To address identified challenges and needs of the Programme Area in a complex way in the chosen sector
- Duration: up to 36 months
- Recommended budget: EUR 1-2 M
- Small-scale projects
  - To address challenges and needs of the Programme Area while focusing on newcomers, not very experienced partners, small organizations, NGOs
  - Duration: up to 18 months
  - Budget: up to EUR 0,2 M
  - More details to be specified in dedicated Terms of Reference
- Seed-money projects

# 2<sup>nd</sup> Call for proposals (**regular projects**)

- **5**<sup>th</sup> October 2023 30<sup>th</sup> November 2023
- open for all Programme Measures
- projects should put special attention to identified challenges and expected solutions within each Measure
- In the Measure 2.3 it is obligatory to plan activities dedicated to support enterprises and thus to contribute to output indicator RCO04 Enterprises with non-financial support
- Decision on projects' selection: 18 April 2024




# 1<sup>st</sup> Call for proposals for **Small-scale projects**

- 22 February 21 March 2024
- Simplified projects nature: 1 work package, real staff costs and 40% flat rate (project budget up to 200 000,00 EUR)
- SMEs cannot be involved as regular partners
- Dedicated Terms of Reference
- Expected decision on projects' selection: 27 June 2024
